# Biographical and Historical Note

Lillian Serviss Gregory was born in Lisbon, New York, in 1914. She graduated from the Baptist Missionary Training School in 1937 and from there went to Hartford Seminary's School of Religious Education. She was ordained a Congregational minister in 1945 in Lowell, Vermont. In 1953 she took the position of Associate Secretary with the National Fellowship of Congregational Christian Women, and was promoted to Executive Secretary in 1957. In 1963 she was named Director of Women's Work and Co-Executive of the Council for Lay Life and Work of the Massachusetts Congregational Christian Conference.

The National Fellowship of Congregational Christian Women (NFCCW), which Gregory lead for six years, was created from the merger of Home Missionary Unions and Women's Boards of Missions. Missionary Societies developed in the early 19th century as churches sent men and women to the west. Women's organizations on local and statewide levels raised money to support the missionaries. By 1885 there were 14 women's state Congregational Home Missionary Unions, and they joined into a national federation in 1905.

At the same time, other women raised funds for the American Board of Missions to send missionaries overseas. In 1868, the Woman's Board of Missions was organized to receive gifts from state branches and local auxiliaries. The National Council of Congregational Churches prompted the unification of these two women's organizations in order to increase efficiency.

In 1925, the Council of the Congregational Christian Church voted that national women's boards be consolidated with general mission boards in the Commission on Missions; the Woman's Board of Missions was under the American Board of Commissioners for Foreign Missions which represented them on the Commission on Missions. In addition, the Council stipulated that one-third of the membership of all governing boards and committees be women in recognition of the role of women in the church. The actual consolidation took effect January 1, 1927.

In 1936, the Commission on Missions became the Missions Council. The Woman's Board of Missions was dissolved in 1949 and Woman's Work became part of the Missions Council. The Missions Council consisted of the directors of the Board of Home Missions, American Board, Service Committee, and Council for Social Action.

It was not until 1953 that a separate woman's organization was formed within the structure of the Congregational Christian Church as part of the Missions Council. That year marked the founding of the National Fellowship of Congregational Christian Women, with Margaret Hargrove as Executive Secretary and Lillian Gregory as Associate Secretary. The fellowship adopted its constitution in 1954, and described as its purpose "To cultivate the spirit of Christ, beginning with our own lives and reaching out into home and community and the uttermost parts of the earth." It further stated that "To carry out his purpose, women's organizations undergird and participate in the entire program of the denomination. This process begins in the local church and extends to associations, conferences, the denominational Boards and Agencies, and the General Council."

The organization of the fellowship was complex. The Woman's Work Committee acted in an advisory capacity. It was composed of staff members of the Missions Council and other boards and agencies to counsel with the staff of the Women's Fellowship. The Presidents' Conference, composed of State and Conference Presidents, national elected officers and Area-of-Work chairmen, was the basic, responsible group which adopted policies and planned programs. It also provided leadership training workshops.

The Executive Committee consisted of the president, two vice-presidents,

the recording secretary, chairmen of standing committees, seven members at large, and the secretary and associate secretary of Woman's Work of the Missions Council. A Business Committee transacted business between meetings of the Executive Committee.

Standing Committees of the fellowship included Nominating, Program, Area-of-Work Chairmen and Committees, Stewardship (including Woman's Gift which started in 1941 under the Woman's Board of Missions), Christian Social Action, and Missionary Education. Program areas included Evangelism and Spiritual Life, Stewardship, Christian Education (emphasizing family life), Missionary Education, Christian Social Action, and Friendly Service. The fellowship offered numerous opportunities for leadership training through the President's Conference prior to the Mid-Winter meeting of the Missions Council; pre-sessions at regional meetings of the Missions Council; pre-sessions at General Council; and other conferences and seminars. The fellowship also published its own newsletter, Guide Posts.

The Woman's Fellowship, while intricately involved with the activities and governance of the Missions Council, also participated with international and interdenominational organizations. The Executive Secretary represented the Fellowship on the Division of Home Missions and the Joint Department of Family Life of the National Council of Churches in Christ in the U.S.A.; served as a delegate to the World Council of Churches; and the National Fellowship was part of the Women's Fellowship of the International Congregational Council.

The Fellowship maintained two offices, one in New York, and one in Chicago. Lillian Gregory staffed the Chicago office when it opened in 1956, first as Associate Secretary, then as Executive Secretary. In 1957, Gregory had the assistance of Lucille Frost as Associate Secretary, and Mildred Walker as Administrative Assistant.

Following the merger of the Congregational Christian Church and the Evangelical & Reformed Church, the Women's Fellowship operated within the framework of the newly formed Council for Lay Life and Work from January 1, 1962 to January 1, 1963 as the National Women's Fellowship. The Chicago office closed January 1, 1963, and the records were transferred by Lillian Gregory to the Congregational Library when she moved to the Massachusetts Conference.

#### SCOPE AND CONTENT NOTE

The Lillian S. Gregory Collection consists of records assembled or generated by Gregory in her capacity as Associate and then Executive Secretary of the National Federation of Congregational Christian Women, and as Director of Women's Work for the Massachusetts Congregational Christian Conference. Also included in the collection are records collected by Mrs. Sally Medlicott as Executive Secretary of the Missions Council from 1937-1951 and as author of a history of the Women's Fellowship.

The collection is arranged in sub-groups representing the major organizational divisions within which the Women's Fellowship operated, in hierarchical and rough chronological order. Series and sub-series are generally arranged in order of importance or date, and materials within the series are arranged chronologically, unless otherwise noted. The collection as it came to the Congregational Library was arranged in long cardboard file drawers, with little logical organization, with the exception of correspondence and meeeting files from Miss Gregory's years at the Massachusetts Conference.

Therefore, the creation of sub-groups is somewhat artificial. In most cases, the integrity of individual files were maintained, and folder titles were copied exactly. Items that were stapled or paper clipped together were kept together with plastic clips or with folded pieces of alkaline paper. Newspaper clippings and thermofax and other fragile photocopies were recopied onto alkaline paper and the originals destroyed.

Sub-Group I consists of General Council Records, 1913-1963, including a digest of Executive Committee actions (from Medlicott), 1913-1947; and meeting programs, reports, addresses, and articles, including programs for

and by women, 1954-1958.

The records of the Missions Council are arranged in Sub-Group II. They consist of minutes, reports, and schedules of Mid-Winter meetings, 1953-1962 (some copies marked as either Mildred Walker's or Lillian Gregory's); programs from annual dinners of the Board for World Ministry, 1956-1961; and memoranda and lists, 1960, ca. 1962.

Sub-Group III encompasses the records of the Council for Lay Life and Work, the sucessor to the Missions Council after the merger with the E&R Church. These records include information on the history and formation of the Council, 1957-1962; and agendas, minutes, and reports of meetings, as well as an informational "PAC/Kit", 1962-1963.

The bulk of the collection consists of materials generated by the National Fellowship of Congregational Christian Women (NFCCW), arranged in Sub-Group IV. The first three series consist of drafts of the Constitution, as well as copies of the fellowship's manual, 1944-1962; minutes, correspondence and reports of the Women's Work Committee, 1937-1957; minutes, workbooks, program materials, and lists of state presidents of the Presidents Conference, 1937-1962; and minutes, agendas, and meeting materials for the Executive Committee, 1955-1962. Series E encompasses correspondence, reports, and memoranda produced by various presidents of the fellowship from 1953-1960. The correspondence of the Executive Secretaries is arranged in Series F; Margaret Hargrove's is organized into sub-series 1, 1952-1956, and Lillian Gregory's into sub-series 2, 1955-1963. Both sub-series are arranged alphabetically by name of correspondent, with Miss Gregory's futher sub-arranged by year. Neither collection extends beyond the letter M. Correspondence is preceded by reports, circular letters, and in the case of Miss Gregory, by her working notebook. Gregory's correspondence also includes files for individuals with whom she had a great deal of correspondence during one year, although that name will appear in the alphabetical files for other years. In addition, her files contain correspondence from administrative assistant Mildred Walker and secretary Margaret Boise, as well as some letters from the time when Gregory served as Associate Secretary.

The records of the Associate Secretary, 1952-1958, in Series G, consist of circular letters and reports written by Gregory and by her successor, Lucille D. Frost. Mildred Walker's correspondence and reports as Administrative Assistant, 1959-1963, can be found in Series H. Letters, memoranda, agendas, and minutes prepared by the Recording Secretary, 1958-1963, are organized in Series I. Financial Records, including budgets, statements, and correspondence, 1956-1962, constitute Series J.

Records and program materials generated by standing and other committees of the fellowship are arranged in Series K, 1941-1962. Some of these materials were collected by Sally Medlicott as part of her research into the history of the woman's group. The standing committee records are arranged first, in the order found in a descrption of the fellowship, followed by other committees in alphabetical order. Included among the committees are the Stewardship/Woman's Gift Committee, with reports, statistics, and promotional

materials, including a film strip, for the Woman's Gift project; Missionary Education; Christian Social Action; Friendly Service; and Leadership Training.

Series L, 1960-1963, consists of reports from various committees and individuals. Arranged in roughly chronological order are the correspondence, programs, articles, agendas, minutes, and reports of various programs, conferences and resources sponsored by the fellowship, 1927-1962, in Series M. Publications by the NFCCW, as well as similar publications from other denominations, constitute Series N, which is arranged by type of publication. Included among the publications, dating from 1939-1963, are plays and skits purchased for use in programs at the national, regional, and local level, and provided as a resource.

Series O encompasses materials related to the merger of the Congregational Christian Church with the Evangelical & Reformed Church. It includes minutes from the Women's Committe on the Merger of the E&R Church, drafts of the UCC constitution, informational material developed by the denomination, and records of the Committee to Study Friendly Service and Christian Service and other joint committee records.

Sally Medlicott's historical materials are arranged in Series P, with materials that date as early as 1860, to 1961. This material seems to have come separately from the files of NFCCW and Massachusetts Conference materials, but was evidently forwarded to Lillian Gregory in 1969. The materials were found in loose files and bundles on shelves in the third floor stacks of the Congregational Library.

Files containing correspondence were placed first, followed by research files in roughly chronological order, and finally by materials gathered from each state or regional conference, arranged alphabetically. Topics covered include missionary efforts, women's clubs, conferences for women, Woman's Gift, and United Church Board for World Ministries. The resources Medlicott collected encompass printed histories and informational brochures, articles and essays, reports, correspondence, minutes, scrapbooks, and photographs.

The final Series in this Sub-Group consists of articles written by Polly Harrington and Emily Lester, 1959-1962, for the <u>United Church Herald</u> in Series Q, and biographical information on Lillian Gregory and Berta McClintock, n.d., in Series R.

The NFCCW worked closely with several national and international church organizations. Materials that document this relationship are arranged in Sub-Group IV, National and International Women's Organizations, 1938-1963. The organizations whose records exist include the National Committee of Church Women, 1938-1945; United Church Women, 1952-1963; the National Council of Churches, 1955-1961; the Commission of Missionary Education of the National Council, 1955, 1960-1962; the Christian Higher Education Fund, 1959-1960; Women's Fellowship Tours, 1956-1961; the International Congregational Council, 1949-1958; and the World Council of Churches, 1961. Records include minutes, correspondence, brochures, program materials, photographs, and news clippings.

When the UCC merger closed the Chicago office of the NFCCW, Lillian Gregory moved to Boston to head the Woman's Department of the Massachusetts Conference. The records generated during her tenure or which she inherited are arranged in Sub-Group VI, Massachusetts Conference of Churches, 1936-1964. Series A consists of minutes of the Executive Committee, 1962-1964. Series B contains materials from the 1963 and 1964 annual meetings. Business Committee minutes are arranged in Series C, 1962-1964. Minutes, correspondence, lists, brochures, resource materials, and essays constitute the records of the Christian Education Committee, 1938-1963, arranged in Series D. Series E, Christian Family Committee records, 1957-1964, include bulletins, lists, correspondence, and resource materials. The Christian Social Action Committee

is represented by records, 1936-1963, which include resource materials, correspondence, and minutes. Quota records and assignments, as well as information about various "missions," constitute the records of the Friendly Service Committee, 1943-1963. The records of the Program and Nominating Committees encompass two informational pieces, 1957, 1962, and a report, 1963.

The final and largest series in this Sub-Group consists of a chronological file of speeches, meetings, and presentations which Miss Gregory made or attended, or to which she was invited. The materials date from 1966 to 1968 and include correspondence, programs, and copies of her speeches.
