| Charles Merrill was a member of the Commission on Ministry from 1927-1934, and the Board of Pastoral Supply from 1934-1943. The collection contains material produced and collected by Charles Merrill during his career in the Congregational church, including his work as a pastor and his advocacy of the United Church of Christ merger. |

Historical Note

Description

Charles Clarkson Merrill was born in Marlboro, New Hampshire on March 3rd 1872, attended Yale Divinity School, and was ordained through the Congregational Church of Stubenville, Ohio in 1897. He was pastor there until 1902, then at North Church in Winchendon, Massachusetts from 1902-1911. He became secretary of the Vermont Conference in 1917, of the Illinois Conference in 1922, of the Commission on Missions in 1927, and finally the Congregational Board of Pastoral Supply in 1934, a position he held until his retirement in 1943. He convened, chaired, and was a member of the Committee on Interchurch Relations and Christian Unity from 1946-1958, and a member of the Committee on Denominational History from 1947-1958. He died on April 1st 1961.

Scope of Collection

The Merrill collection contains material produced and collected by Charles Merrill during his career in the Congregational church, including his work as a pastor, his time on the Commission on the Ministry, and his advocacy of the United Church of Christ merger.
