HISTORICAL NOTE

Church gathered in 1771; the Congregational Society formed in 1831. In 1832 a smaller group named the Union Society was formed by local Universalists; little was known of this group except that it was still in existence in 1875. Church incorporated in 1966; the Congregational Society dissolved the same year. Extant as Temple Congregational UCC in 1996.
