## Historical Note

---

The Congregational Christian Church and the Evangelical Christian Church Merger Collection was intentionally collected during and after the events that created the United Church of Christ. As it was a collected over a period of twenty-five years, it remained separate and not as accessible as General Council documentation covering the same period. While at times it mimics documentation found in other parts of the Congregational Library and Archives, its singular focus allows greater detail and access for research into the very important part of American religious history. The merger of the Congregational Christian Church and the Evangelical and Reformed Church, first proposed in 1943, resulted in the

creation of the United Church of Christ, one of the largest church bodies in the United States. Though the initial vote for the Basis of Union between the two congregations occurred in 1948, it was not until 1961 that the merger was deemed complete with the United Church of Christ running as a single body, and the General Council and General Synod of the respective churches dissolved. During this entire process, extensive documentation was created and collected by individuals and official bodies such as Helen Kenyon, Douglas Horton, the Executive Committee, and the Congregational Historical Society. It was an ask from the Historical Society during the 1960's to involved parties that brought in much of the correspondence from Helen Kenyon and opposition leader Malcom K. Burton. Ms. Kenyon was also able to provide her personally notated copies of General Council reports, committee minutes, legal documents, and opposition publications, adding value to similar items collected as official archives. The Historical Society's proactive approach also brought in a considerable amount of published material that was distributed to churches, arguing for and against the union. A very dedicated anti-merger front, led ostensibly by Malcolm K. Burton, stalled the initial vote with publications, speeches, and several lawsuits. The first, and most covered in the press, came from the Cadman Memorial Church in Brooklyn, New York against the Congregational Christian Church Moderator, Helen Kenyon. This case was at first successful as the presiding judge sided with Cadman Memorial Church's argument and put a legal stop to any more merger proceedings. An appeal from the Congregational Christian Church followed and the decision was reversed; that judge's ruling reprinted and distributed to show there were no longer legal barriers to the merger. Another suit followed, brought by four Congregational churches and ten individuals (Malcolm K. Burton amongst them) from across the United States against the Evangelical and Reformed church and its Treasurer. This second attempt to stop the merger also failed. While the merger was eventually approved and carried out, it did result in many congregations not joining the UCC and forming new groups like the National Association of Congregational Churches and the Conservative Congregational Christian Conference. The very beginnings of these groups, and their arguments, can be seen via the various correspondence and publications put forth by the anti-merger groups like the Committee for the Continuation of the Congregational Christian Church and the League to Uphold Congregational Principles.

## Scope and Contents

---

The Congregational Christian Church and the Evangelical Church Merger Collection consists of extensive correspondence and publications of Congregational Christian Church councils, committees, and appointed individuals including The General Council, International Congregational Council, State and Local conferences, Helen Kenyon, Arthur Bradford, Albert Palmer, Stanley North, and Douglas Horton. The Collection also contains considerable correspondence and literature from the anti-Merger side of the process; committees and individuals pushing against the creation of the United Church of Christ. The Collection prominently features the Committee for the Continuation of the Congregational Christian Church, League to Uphold Congregational Principles, National Association of Congregational Churches, and Malcom K. Burton, Charles Merrill, Robert Richardson, as well as responses from average parishioners. The Congregational Christian Church and the Evangelical and Reformed Church Merger Collection also contains extensive legal documentation for the Basis of Union, Cadman Memorial Church v. Helen Kenyon, First Congregational of Burlington , Iowa et. al. v. the Evangelical and

Reformed Church, and several other court cases over the creation of the United Church of Christ. Coverage of these cases, and the merger process, are well documented view newspaper clippings collected by Helen Kenyon and the Congregational Historical Society. There are also several manuscripts detailing the process of the merger from after the official creation of the United Church of Christ.

### Scope and Contents

Series II details the specifics surrounding the Basis of Union that was the first proposal for merging the church bodies. The Series includes correspondence and reports on the historical background of the Congregational Christian Church and the Evangelical and Reformed Church; discussion of how to educate the congregations on the postivities of the union; correspondence and research on how the new church will be organized and how to merge the existing councils; reports on votes taken. The Series also contains correspondence and legal documentation on the Cadman v. Kenyon case, First Congregational et al. v. The Evangelical and Reformed Church, and the Andover Newton case.
