## Historical Note

---

The Trumbull Avenue Congregational Church was gathered in 1868. In 1881, the church building was moved to the northeast corner of the intersection of Trumbull Avenue and Baker Street in the Corktown neighborhood of Detroit. After moving to the new location, the church changed its name to Plymouth Congregational Church. The church remained active until 1903 when the church's property was sold to the Detroit Congregational Union.
