Abstract: Organized in 1880, the New West Education Commission was established to promote the Congregationalist religious and social traditions in the western states. This collection contains correspondence from the Office of the General Secretary of the New West Education Commission. The collection also contains the personal notes of Charles Robinson Bliss regarding the history of the Commission.

Description

Historical Note: With the completion of the country's first continental railroad, the pace of westward expansion increased as many individuals and families began their lives anew. Many Congregationalists, as well as members of other faiths, established thriving communities with markets, churches, and schools. In 1880, the New West Education Commission (NVEC) was established to facilitate a new education program within the western states. Taking place within the school, this program would promote and uphold the social and religious wellbeing of Congregationalists. The NVEC established the office of the general secretary in Chicago, Illinois in 1881 with Reverend Charles Robinson Bliss in its charge. Rev. Bliss corresponded with teachers, principals, and clergy in the field through the Chicago office. As the work of the commission increased, a second office was added in Boston, Massachusetts in 1883 working closely with the Congregational Education Society. In 1893 the NVEC merged with the Congregational Education Society.

This historical note has been edited from its original. The original is available upon request.

Scope of Collection: The bulk of this collection contains correspondences between Reverend Charles Robinson Bliss, general secretary of the New West Education Commission, and teachers, principals, and clergy located in western states. Most of these correspondences are in New Mexico and Utah. A complete list of correspondents' names is available in the original finding aid. This scope has been edited from the 1984 original and is available upon request.
